After 28 years of unwavering commitment to Life Steps' mission and our participants, Kristine Engels has stepped down as CEO of Life Steps Foundation SoCal Adult Services based in Long Beach, California. Ms. Engels was ceaseless in her efforts to ensure the well-being of individuals with developmental disabilities and maximize their opportunity to advocate for themselves, live as independently as possible, and participate in their communities.

Kristine's career began in 1968 working as a volunteer for the Fairview Developmental Center planning recreational outings for the women who lived there. Intuitively, she knew she had found her niche. Her initiative and strong work ethic led her to accept offers as chair or member on several committees. She sat on three committees with Harbor Regional Center: Service Provider Advisory Committee, Client Service Committee, and HOPE Board of Directors.



In collaboration with Harbor Regional Center, Ms. Engels also developed the Harbor Friendship Center, a facility where adults with developmental disabilities can meet and participate in positive, meaningful, safe social experiences. From Girl Scouts leader to assistant teacher and from volunteer to committee chair, Ms. Engels has proven countless times to the people she serves that her instincts were good—she belonged in social services. Engels has amassed over 40 years of experience helping children and adults who have developmental disabilities.



Patricia Flores who has been with Life Steps Foundation SoCal Adult Services for over 20 years has been appointed as Program Manager to oversee all aspects of programs and services for adults with developmental disabilities offered at her location. Ms. Flores is delighted to have the opportunity to lead her team as they work together to enhance programs and services for individuals with developmental disabilities. LSF Children and Family Services: Collaborating via Teletherapy: Empowering the Parent to Empower the Child by Neeti Sharma

t made me smile to look at my phone and see a picture of Elisa (name changed) sitting on a wooden rocking boat that her mother built over the weekend. I was so thrilled to see her rocking and enjoying herself, because until last month she was not even able to rock to sleep in her mother's lap when she was sick.

Elisa is an 18-month-old girl who was born with hip dysplasia, Torticollis and sensory defensiveness (her brain gets overloaded with multiple sensory stimuli, and she resists movement, touch and new sounds). Because of her sensory processing difficulties, it is hard for her to explore and learn from manipulating different textures. She is a picky eater and does not like to be held in her mother's arms. Most of her activities end in crying because of her frustration.

When Elisa was a year old, and we were all just a few months into the pandemic, a team of professionals including a physical therapist, an occupational therapist and myself, as an infant development specialist, started providing early intervention services to her due to developmental delays. Given her needs, I was initially concerned about whether offering services virtually would be effective; but considering the new world we were all in, I knew we would have to do our best using remote services.

At first it was difficult for Elisa to participate in services because new faces and voices, even via Zoom, overwhelmed her. My first step was to build trust and a positive relationship, not only with Elisa but also with her mother, Susan. While listening to Susan's concerns and thinking about Elisa's feelings and experiences, I tried to put myself in their shoes. I let Susan know that we would be in this together and soon we started working as a team. We agreed to focus on helping Elisa with communication in order to reduce her frustration and give her a way to experience some control. She had no words yet, so we introduced her to signs like "more", "all done" and "no". To our delight, this was a real turning point. Soon, Elisa knew the power of "no" and it became easy for her to express that she did not like something. Susan was then able to build on this success, adding communication strategies that helped prepare Elisa for new activities while giving her time to process information about what was coming next. Elisa slowly became more flexible, more open to trying and participating in new activities, and able to discover new likes and dislikes.

These days Susan is always excited to talk about Elisa's progress each time we meet. My skepticism about the virtual

services is long gone. In fact, what I have really learned through this experience is the value of empowering parents. It was particularly important in this case because Elisa was so uncomfortable with new faces and voices. Building a collaborative relationship with Susan and offering her tools to use to support Elisa has helped her to feel effective as a parent. At the same time, the skills she has taught her daughter have allowed Elisa to feel less overwhelmed and more capable herself. Best of all, they were having fun and growing closer along the way. Elisa is now walking with support and using signs and ten words. She enjoys rocking herself on the wooden boat that her mother built for her, while her mother sings, "Row, row, row your boat, gently down the stream, merrily merrily merilly merilly, life is but a dream."
